

## LIMITED LIFETIME WARRANTY

For claims against this Warranty, Blinds Please, at our discretion, will repair or replace any part of our custom made ALUMINUM HORIZONTAL, WOOD HORIZONTAL, FAUX WOOD HORIZONTAL, VERTICAL BLIND, WOVEN WOOD SHADE, CELLULAR SHADE, PANEL TRACK OR WOOD AND FAUX WOOD SHUTTERS (herein collectively called BLIND) found to be defective as a result of faulty workmanship or materials for as long as the original purchaser owns the blind. The Warranty does not apply to any blind or parts thereof which fail due to accident, alteration, improper care, abuse, neglect, normal wear and tear, normal color fading due to sunlight, direct exposure to salt air, or failure to follow proper instructions for measuring, installing or operating the blind. Wood products have a tendency to eventually warp when exposed to the elements. We consider this normal wear and tear, and therefore is not covered by this Warranty. Customers should be aware that colors vary from dye lot to dye lot, and may not match sample swatches or colors from previous purchases. This Warranty is limited to blinds installed in residential dwellings and only those blinds sold by Blinds Please. BLINDS PLEASE UNDERTAKES NO RESPONSIBILITY FOR THE QUALITY OF THE BLINDS EXCEPT AS OTHERWISE PROVIDED IN THIS DOCUMENT. BLINDS PLEASE ASSUMES NO RESPONSIBILITY THAT THE BLINDS WILL BE FIT FOR ANY PARTICULAR PURPOSE FOR WHICH YOU MAY BE BUYING THESE BLINDS, EXCEPT AS OTHERWISE PROVIDED IN THIS DOCUMENT. UNDER NO CIRCUMSTANCES SHALL BLINDS PLEASE BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO PERSONAL INJURY, PROPERTY DAMAGE, OR LOST PROFITS OR REVENUE.

TO SUBMIT A CLAIM UNDER THIS WARRANTY, THE PURCHASER MUST SHIP  
THE BLIND TO THE ADDRESS BELOW, TOGETHER WITH THIS WARRANTY.

The purchaser will bear the cost of shipping the blind from its location to the address below, and return shipping to the purchaser's location after the repair or replacement has been completed.

Blinds Please will not have any liability for defective Blinds other than repair or replacement provided for in the Warranty.
